CANCELLATION – 30 DAYS NOTICE

The certificate should contain an endorsement confirming that Avison Young will be notified in writing a minimum of thirty (30) days prior to the effective date of any change or cancellation in coverage.

Note: The standard language at the lower right-hand corner of the certificate is NOT adequate because it does not obligate the insurance company to do anything. A separate, specific endorsement regarding 30-day advance written notice is required or the standard language in the lower right-hand corner of the certificate should be modified.
